Minutes: Rand made a motion to approve the May monthly minutes. Richard 2<sup>nd</sup>. All in favor.

### **Water Operator / Engineer Report:**

Water Testing: All tests came back good.

Usage: In May, 2.2 million gallons of water were used. The current average flowrate was 50 GPM.

Maintenance Log: Maintenance on equipment is up to date. There have been twenty-one 811 call

tickets. There have been 4 water turn-ons.

<u>Old Sauk Well house:</u> Jorgensen has noticed a whining noise at the wellhouse. They found nothing hot to the touch. They recommended SCADA to check into the issue.

<u>Faulty Curb Stop:</u> A faulty curb stop damaged two water meters. Credit was issued for the faulty equipment.

<u>Distribution Valves:</u> HOA will be invited to the July monthly meeting to discuss this subject since it affects both boards.

<u>Phase III Update:</u> Everything is still on track.

<u>Cummins Contract:</u> Laura made a motion to accept the agreement of \$1973.36 for 2024. Richard 2<sup>nd</sup>. All in favor

<u>Wetco:</u> Laura made a motion to accept the agreement for \$6200 for a year including 2 visits per year and 10 hours per month with nothing extra. Rand 2<sup>nd</sup>. All in favor.

<u>Jorgensen:</u> Rand made a motion to accept the \$11,000.00 per month for the Jorgensen agreement. Cory  $2^{nd}$ . All in favor.

Pay Requests: Dustin handed out paperwork to be signed for Phase III.

## **Financial Report:**

<u>Presentation of Bills:</u> Rand went over invoices and passed out checks needing double signatures.

<u>Transfer of Money:</u> Laura made a motion to move \$39,296.73 from the operation account to the loan repayment account. Cory 2<sup>nd</sup>. All in favor.
